Local and Regional Business Members

A Local and Regional Business membership of ZWA costs \$330 inc. GST per year.

Corporate "C" Member

Small Business Members

These Business members are those that are small sole proprietor business' and partnerships.

A Small Business membership of ZWA costs \$110 inc. GST per year.

Australian Government Department Members
